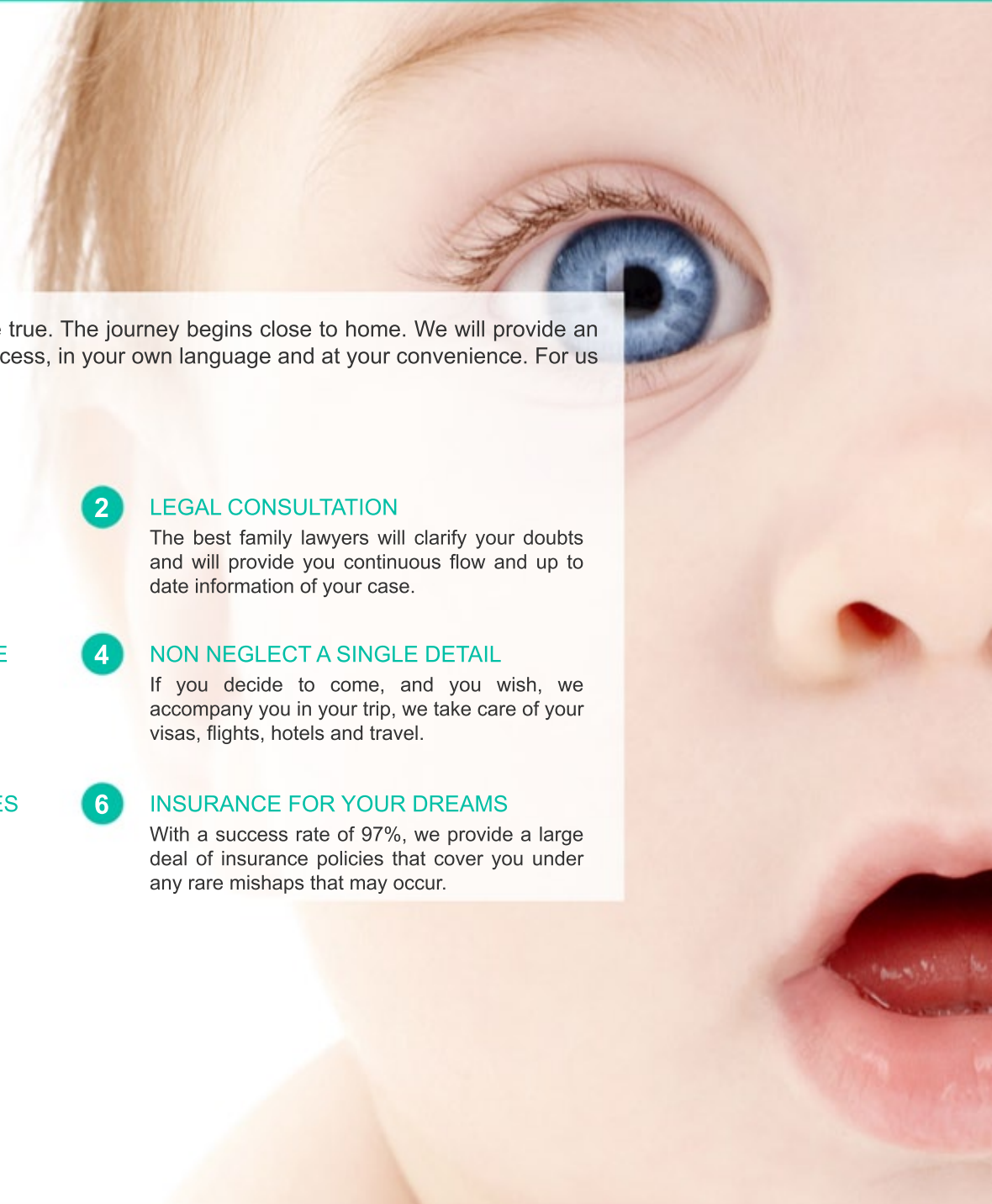

1 BOOK A CONSULTATION

Get all the information you need before making a decision. You can call us in complete anonymity or we can give you a call. If you prefer, you can visit us in person at one of our nearby offices and have a more personal session with one of our trained professionals. The goal: to understand the process of surrogacy. We will get you all information needed including who our surrogates are and what will happen if you decide to start the process.

3 CHOOSE YOUR SURROGATE

Choose the surrogate with whom you feel the most comfortable. We carefully help select the person who will carry and deliver your child. We have a rigorous screening process, one in which less than 2% of the applicants pass. We know how vital the surrogate is in this process and we want you to feel completely comfortable with her. As a result of this, we ensure our surrogates are willing to do this because they truly care about affecting a change in the world and are completely dedicated to assisting people like you in creating a family. We make sure our surrogates are reliable and come from a fine background. By selecting the surrogate you feel completely comfortable with it will make help make this process as smooth as possible. It is a very important choice and by selecting a surrogate whom you are completely confident will take care of herself and in turn your future child will make the process as trouble free as possible. The choice of the donor is an important process and you will see that it is not a simple choice. We have various fertility options including semen banks and egg donors that you can use depending on the type of family you are willing to create. Our company will provide the best professionals for each process but as always, the decision is up to you.

5 THE MEDICAL PROCESS

Your dreams will become a reality. Once you have verified that you have chosen a suitable surrogate, you now must provide the care and funds for the donor, surrogate and other professionals involved in the process. All costs are administered through a unique Trust account account made just for you. Once the funds for the donor's medical bills are received the surrogate will start. As with this process, the creation of embryos could delay a few weeks depending on the biological cycles to which the persons are subject to. After creating and implanting embryos, the average period of confirmation of pregnancy is between 10 and 15 days. After eight weeks of confirmed pregnancy by a specialist in fertility clinic, the surrogate will be referred to a specialist in obstetrics of their choice. Please don't forget to select a health insurance plan to cover any contingency.

2 IF YOU DECIDE TO PROCEED

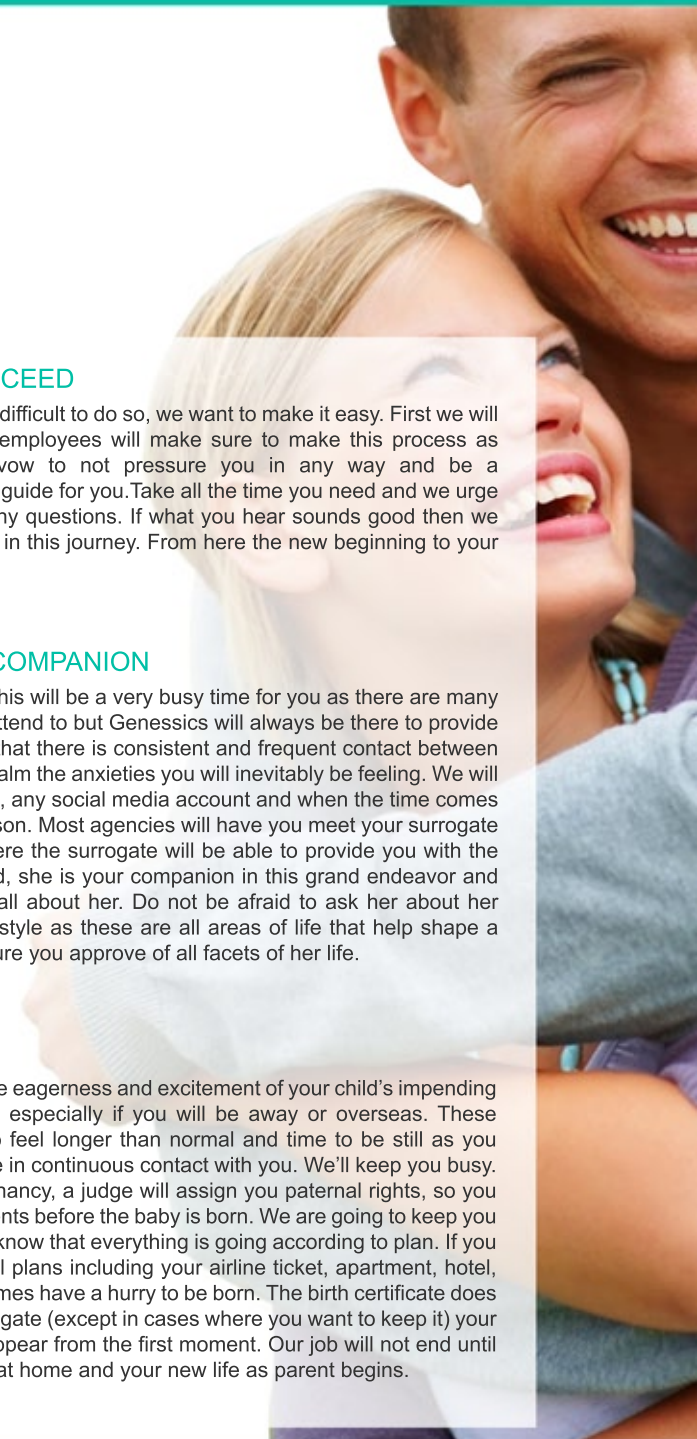

4 KNOW YOUR FELLOW COMPANION

Meet your surrogate. We know this will be a very busy time for you as there are many emotions and duties you must attend to but Genessics will always be there to provide a helping hand. We will ensure that there is consistent and frequent contact between you and your surrogate to help calm the anxieties you will inevitably be feeling. We will arrange contact by phone, email, any social media account and when the time comes you both feel ready, meet in person. Most agencies will have you meet your surrogate for the first time in an office where the surrogate will be able to provide you with the best impression. As already said, she is your companion in this grand endeavor and we recommend that you know all about her. Do not be afraid to ask her about her environment, her family, her lifestyle as these are all areas of life that help shape a person and you want to make sure you approve of all facets of her life.

6 DURING PREGNANCY

Time to prepare for childbirth. The eagerness and excitement of your child's impending birth can cause some anxieties especially if you will be away or overseas. These anxieties can cause the days to feel longer than normal and time to be still as you begin to fret. Don't worry! We are in continuous contact with you. We'll keep you busy. During the early months of pregnancy, a judge will assign you paternal rights, so you will legally be defined as the parents before the baby is born. We are going to keep you posted because we want you to know that everything is going according to plan. If you wish, we can arrange your travel plans including your airline ticket, apartment, hotel, etc. Be proactive. Babies sometimes have a hurry to be born. The birth certificate does not include the name of the surrogate (except in cases where you want to keep it) your name and that of your partner appear from the first moment. Our job will not end until you and your baby arrive safely at home and your new life as parent begins.



Selection of Donors

Selecting the appropriate donor is not a simple task. There are many factors that affect the choice depending of the characteristics the donor must have and the attributes that we want to give our future son.

All parents desire our children to have the best qualities possible. We want our children to be appealing and attractive, have a great personality and have interests similar to ours. Donor selection gives you the possibility to pick and select for certain traits, skills or knowledge to help our children be as amazing as they are. Review the donor's medical background considering that those with genetic abnormalities that may cause future illness are accepted.

We suggest that you choose a local donor. If your donor lives in another state there is a small additional cost for travel and accommodations that the intended parents need to support.

You may also want to know...

Depending on your ethnicity, physical, intellectual and psychological factors, we offer a wide data base selection where we will find the donor that best fits your expectations.

All donors receive more detailed information about the process of extraction of ovules. They are always assisted by a psychologist who oversees their emotional state and ensures the continuation of the process.

IT IS IMPORTANT THAT YOU KNOW THAT YOU DO NOT HAVE TO SELECT A DONOR IF YOUR ANALYSIS SHOWS THAT YOU ARE FERTILE. YOU CAN BE YOUR OWN DONOR AND TRANSFER THE EMBRYOS TO A SURROGATE MOTHER.

Over a decade ago, one of our first patients, decided to freeze healthy eggs prior to a battle with a cancer that would no longer grant her the opportunity to have children. After successfully conquering the sickness, some of her embryos were created with the semen of her actual partner and had a twin pregnancy for the subrogation method.

Speaking about the cost is relative as there is large variance that occurs depending on the selected donor. All this information can be found in detail for each donor. After our initial interview we will provide you a username and a password for the database.



Choosing a Surrogate

One of our most important concerns with our surrogates is the previous selection of the women applying for the program.

For Genessics that you will achieve your goal is as important as for you and we feel responsible for all stages of the process. The surrogate will take your child during pregnancy. The well-being of the surrogate, a proper medical supervision and the fulfillment of obligations that it acquires ensures a more wholesome and healthy son.

Intended parents are free to maintain an ongoing relationship with their surrogate. If there is good communication between both the experiences you will be able to enrich your relationship. Other parents prefer to interview her and that the agency will mediate in communications. Intended parents are free to choose the kind of relationship they want to have with the surrogate during pregnancy, delivery and if they want she will have any connection with your child in the future.

You may also want to know...

In our selection process, we request that the surrogate has kept at least one successful birth. We ensure the surrogate has a family life and a stable emotional environment. Investigate whether they entertain habits such as tobacco, alcohol or drugs.

We demand economic stability to prevent the candidates from reaching out to the program only for economic gain.

The surrogates are followed by a psychologist and a "Case Manager" whom will check continuously her evolution and will be available for the surrogate 24-hours a day, seven days a week. To access the database of the surrogate and, for privacy reasons, you will need to request a username and password. If you already requested information you should have the login and password.



Becoming a surrogate. What's the process?

Gestational surrogacy is the conception of one or more embryos generated by assisted reproduction methods in favor of other couples or singles. Help fulfill a noble cause and allow others to achieve the family they desire. Let us be realistic, solidarity sells a lot and may be used as an argument to improve the sales related with subrogation.

Being a surrogate not only fulfills one's moral duties but it can be extremely economically beneficial. With the benefits gained from your collaboration you can achieve goals like helping to finance your home, start a new business, ensuring the education of your biological children in the future, and support your undergraduate studies.

On a few occasions surrogacy becomes a primary source of income for certain individuals.

Many agencies take advantage of these precarious situations by offering a very convincing compensation to the surrogates. In Genessics we negotiate with intended parents a reasonable cost that permits economic stability to the surrogate. Also a fair payment provides the parents the security that their son will have the best care during the pregnancy.

Requirements for your acceptance

You must be a biological mother and have a genetic predisposition for pregnancy and childbirth.

You must be between the ages of 21 and 39 years old.
Must have a Body Mass Index (BMI) between 30 and 32.

Regular menstrual cycle.
Do not ingest drugs or be smoker.

Be prepared to pass a medical examination with your partner.
You are emotionally and psychologically stable.

Have reliable transportation.
Be financially stable and not receive financial assistance from the State.

Medical Treatment

The three most important stages of medical treatment are the initial checkup, implanting the embryo and giving birth.

1 MEDICAL CONTROL

After finishing the check-up process in the program you will be referred to the fertility clinic to take the corresponding medical exam. You will receive the results approximately two or three weeks later.

2 INTENDED PARENTS

We will present the profiles of intended parents and we will organize a meeting with them so you may get to know each other in person. If both parties are satisfied and agree to the established terms then we will proceed with legal agreements.

3 THE BEGINNING OF THE CYCLE

Once completed, ensure all documents are signed by both parties and the attorney, and only after this is the process ready to proceed for the preparation of implanting the embryo..

4 PREGNANCY

After 8 weeks of pregnancy you will be monitored by a specialist in obstetrics that you will visit regularly and will inform the Agency and the intended parents.



Egg Donors

With so much information available, it is important to be able to understand the process of egg donation in a simple manner.

Our fertility clinics have completed thousands of treatments, making each a unique experience according to the characteristics of the donor. We'd like to explain what the process is in a few simple steps before you make a decision with regard to the beginning of your donation.

It is important that you understand that the donation involves a process of medical screening. Not all potential donors are selected. As with any medical treatment there are risks associated with egg donation.

Before signing a contract on egg donation you are entitled to receive specific information about the treatment.

NEVER SIGN A CONTRACT WITHOUT FIRST CONSULTING A PHYSICIAN AND AN ATTORNEY.

Egg Donors: Basics Concepts

1 WHO CAN BE AN EGG DONOR?

Any woman between the ages of 21 and 29 years old with proper muscle mass index, high levels of health and no history of genetic disorders can be an egg donor. These women must adhere to FDA regulations on human tissue donation. Finally you must have a flexible schedule to attend medical appointments and strictly follow the instructions of the doctor. If you are currently following a birth control plan you can continue the same until there is an established contractual relationship with the prospective parents. If you are currently on a medical treatment plan, it must be confirmed with the fertility clinic that the treatment does not interfere with the donation process. Most D.I.U. does not exclude you from participation in the program.

3 WHAT HAPPENS AFTER I SUBMIT THE FORM?

Once you submit the form we will review it and contact you within two business days. During our first call will gladly take the opportunity to answer any questions that you may have and we give you a full explanation in detail about the process. You will then receive some documents that must be reviewed and approved. We partner with fertility clinics available in most countries to administer the appropriate psychological, intelligence and personality tests required. Intended parents seeking a donor want to find one with similar physical characters to themselves. We will put together a portfolio for you including some personal pictures you may wish to include as well as a photo-shoot we will provide. This portfolio is to give the intended parents a little more insight into you and become more familiar with you before they make a decision. If you want we can also create a video for you. In most cases, intended parents are seeking personality traits that are similar to themselves and a video can be a great way to convey more information to them.

5 IMPORTANT THINGS YOU SHOULD KNOW

The process takes between 2-4 months since your selection as an egg donor. If you are concerned about the medical risks we will happily address any apprehensions you have at all times. You will be provided with the best care, but like any medical process it involves a risk. We recommend a period of abstinence of 3 to 4 weeks before extraction. If the experience has been morally and economically satisfactory to you, you can opt for new donations waiting between each two regular period's cycles. Again, your donation can be completely anonymous and you do not need to have a relationship with the intended parents. Your true identity will never be disclosed and your name will appear as a pseudonym. Your generosity will always be appreciated with fair compensation. Before starting any process intended parents have deposited with the agency the amount of your expenses and compensations.

2 ECONOMIC COMPENSATION

It's never easy to talk about money. For the first donation process you will receive a minimum of \$ 8,000 and \$ 10,000. **THIS IS NOT A MAXIMUM PRICE.** The choice of donor is performed by the intended parents so this price is negotiated with them in terms of the exceptional qualities that the donor offers (physical traits, IQ, history of successful pregnancies, etc.). Donors of ethnic minority whose location is not as easily accessible can lead to higher compensation rates. The terms of compensation negotiated between the parents and the donor include medical, travel, and accommodation fees.

4 HOW LONG DOES THE SELECTION PROCESS TAKE?

Your profile will be stored in a secure database where intended parents have access for a limited time. Typically, the more information you provide for us to offer on the database the faster the selection process goes. As mentioned above, a video profile of yourself and your family photographs, reports about your grades will help increase your chances of being selecting over other candidates. We all want to give our children the best qualities. Beauty, intelligence and empathy are some that are very strongly valued. Your anonymity is protected but you are free to get in contact with the intended parents if both parties agree. You can also allow us to include your listing in our international database which is available to people around the world. If you like to travel this is a method for visiting new places at no cost to you. You can also opt for single donation in your state.

6 ADDITIONAL INFORMATION

If you have a sexual relationship with another person or persons, you must ensure precautions be taken to prevent the transmission of diseases. The extraction process is not painful and doesn't require you to be hospitalized. If you want, you can be sedated to avoid discomfort. Throughout the process you are protected by an insurance policy. Some women may experience minor discomfort after the extraction but this is rare and depends on the characteristics of each person. Not all women react the same way during and after the process. Doctors will perform tests and screenings to determine the appropriate path and make this a simple, comfortable experience for you. Financial situation are a strong motivation for donors, however our number one priority is providing donors who are completely dedicated to producing new life for those who are not fortunate enough to do so on their own.



Legal Information

Legal Information: Process

If you have read the information for intended parents, please be advised than the process is:

1 GESTATION

During pregnancy a judge will award a stance of recognition for the parental rights to the intended parents more worried about giving birth than for the legislation.

4 CITIZENSHIP

It is certain that the day of the birth the American Government and the American citizen will provide his Social Security Number to your baby and giving birth certificates sent by the State of California.

2 BIRTH

At the time of the birth, with the ruling in hand, the hospital corrects the name of the child from the name of the delivering woman to the name of the intended parents.

5 FLIGHTS

Find out the maximum time in which you can fly while pregnant and if you need to declare the pregnancy at the time of the trip.

3 MARRIAGE

If you are in a same-sex marriage the Consulate will try that neither one of the party have given birth..

6 RESISTRATION

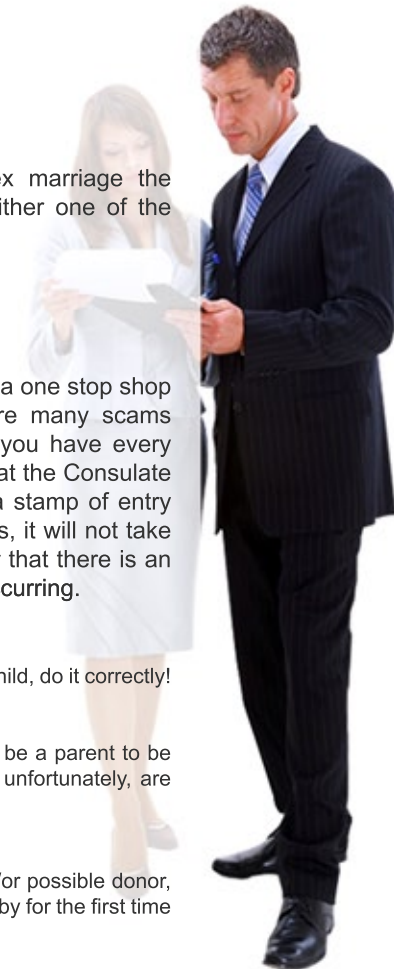
Be wary of places offering a one stop shop for surrogacy as there are many scams around the globe. Again, you have every right to register your child at the Consulate but if your Passport has a stamp of entry into the country a few days, it will not take much investigating to infer that there is an immoral surrogate case occurring.

That is why it is very important to be well prepared from a legal stand-point early on as to avoid any further legal complications or battles. If your goal is to have a child, do it correctly! Make sure you defend for your rights.

Analyzing companies that offer low cost treatments, you'll see that we offer the same services for 27,000 Euros in India, Thailand and Ukraine. If you want to be a parent to be successful first visit to these countries. The consulates will not only prohibit the surrogacy but also advise you not to go, especially in those places where, unfortunately, are experiencing a civil war.

Try to imagine the conditions a pregnant woman living in these areas must deal with. We know this is not what you want for your child?

And we approach the case from the moment you decide to be parents. The gestation process is relatively simple and by correctly selecting your surrogate and/or possible donor, many of the stresses of this situation can be decreased. At Genessics we hope the only stress that you will undergo is the growing anxiety to see and hold your baby for the first time and this can all happen if you start by carefully and legally planning the situation for you and your future children.



Countries where laws between the surrogate and parents differ

An egg donor is similar to an organ donor, lending his body to others so they can achieve betterment in their lives. In gestational surrogacy, the sperm and the egg come from third parties and the embryo is then implanted into the surrogate. In regard to certain legalities, some countries allow NON-PROFIT or subrogation by relatives where the mother has no genetic link to the baby. This, together with the development conditions of the country are the main differences in the legal regulation.

In Spain there is a contractual relationship between a pregnant woman and prospective parents. According to Spanish legislation, Spain acknowledges a mother to be one who gives birth to the child regardless of their genetic relationship with it. If you're considering this method to achieve parenthood and you have already read the legislation of Spain, ensure you know the law in the various countries also where the child may be prospectively born. According to existing legislation, Spain does not constitute it a criminal or administrative offence if a Spanish citizen uses gestational subrogation in another country.

There are several options for the latter:

1 UNITED STATES OF AMERICA

A court case in 1993 proved to be a landmark case in surrogacy regulation in the United States. It was here in the State of California where a custody case was ruled upon by the State Supreme Court which helped more clearly define the definition of motherhood. The State Supreme Court issued a ruling which gives the parents and not to the surrogate mother parental rights to the child. To continue by this method a legal contract must be prepared accounting for for any accidents at the beginning of the process. The drafted contract will be ruled on in a court of law during which the Court proclaims a judgment granting paternal and maternal rights of the fetus to intended parents.

The pregnant woman has no rights to the child and the parents cannot waive the parental rights obtained upon implantation of the embryo in the uterus. Surrogacy is illegal in some U.S. states and is regulated differently in the states that allow it. Illinois and California are the states with more favorable rules. The advantage of California is that the parental rights are granted before birth as opposed to Illinois where the parental rights are granted after child delivery. The laws and regulations in other states are highly variable where some states have restrictions and limits to those with no judicial control over the process.

2 UNITED KINGDOM

It is a technique permitted where the surrogate may be related with the intended parents but there cannot be any compensation to the surrogate.

5 MEXICO

Allowed in two states but it is illegal to provide compensations of any kind to the surrogate.

3 BRAZIL

Allowed between relatives up to second degree of consanguinity.

6 RUSSIA

The technique is legal but the surrogate mother gives up parental rights when the baby is delivered. There have been cases in which the surrogate has refused to give the parental rights to the intended parents and the government recognizes it to the surrogate.

4 THAILAND

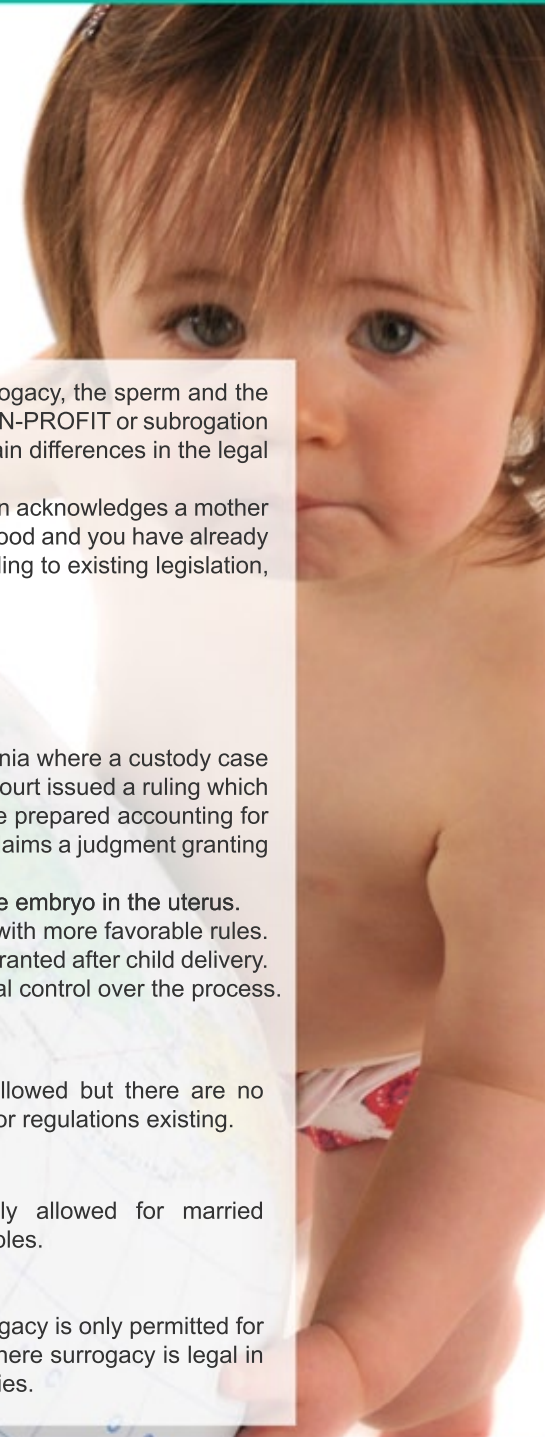
The process is allowed but there are no legal guarantees or regulations existing.

7 UKRAINE

Surrogacy is only allowed for married heterosexual couples.

8 INDIA

Since 2013, surrogacy is only permitted for foreign citizens where surrogacy is legal in their home countries.
